Mr. Jenkins and Mr. McGaugh:

Below are concerns of photographers, planners, officiants, brides, grooms, and local business owners over the most recent restrictions.

We would like to request a meeting with you to discuss the most recent changes specifically to the Commercial Use Applications (CUAs) now being required for portrait & wedding photographers within Grand Teton National Park.

This is our written appeal to the park for your review, prior to our meeting:

Our Appeals

- 1. Rescind Unconstitutional/illegal Policies
- 2. Allow Photographers At Dispersed Ceremony Sites
- 3. Discuss Permit Caps, Locations & Times
- 4. Remove limit Of 1/2 Mile From The Trailhead/Parking Lots
- 5. Remove requirement for Commercial Use Authorizations

Who We Are

We love our National Parks and we are committed to protecting them while preserving access, without discrimination, to the public. As small business owners, we are advocates for our National Parks and are often our clients first and strongest source of information regarding conservation, outdoor recreational ethics and Park policy. It has been our hope to work alongside Park officials for the betterment of Grand Teton National Park (GTNP) and the "benefit and enjoyment of the People."

We regard, respect, and love this splendid place and feel that we have much to offer by way of alternate perspectives, ideas and insight that would be an asset to the Park. As persons who luckily get to spend a considerable amount of time in GTNP, we witness firsthand a multitude of issues plaguing the Park and are often the eyes, ears, and voices that call attention to the problems and violations we see that jeopardize the integrity of GTNP as a whole. We fully understand that the growing interest in the Park comes with many ramifications and we are eager to discuss ideas and solutions with you that protect the lands and also the peoples rights to access and enjoy those lands.

Our Concern

The sudden, all encompassing and unreasonable changes made to the guidelines for ceremonies in GTNP as well as the CUA process is alarming at best and unjust at worst. We understand that, our once quiet and undiscovered GTNP, is now experiencing unprecedented visitor numbers and that Park officials are scrambling to manage these ever changing times while implementing procedures and policies meant

to protect the Park and preserve the visitor experience. However, we also feel that somehow in this process, wedding ceremonies have been erroneously targeted as a major source of GTNP's issues resulting in excess and prejudicial blame, as well as overreaching restrictions that severely limit and impact the visitor experience. Our clients are also members of the public who want to experience GTNP in a special and meaningful way. Throughout this process, there is also a growing concern that wedding professionals have been specifically targeted and discriminated against by GTNP. Vague, murky, ever-changing rules, confusion and fear color us as we look to 2022 as being disconcerting and ambiguous. Please read our appeals to GTNP in the following details to hear our frustrations and our solutions.

Appeals Detailed

APPEAL #1. RESCIND UNCONSTITUTIONAL/IIIEGAL POLICIES

Background:

Please see the letter written by NPPA on 3/1/2022 that states clearly most recent GTNP 2022 policies are both unconstitutional and illegal policies per code 54 U.S.C. § 100905(c)(1)

APPEAL #2. ALLOW PHOTOGRAPHERS AT DISPERSED CEREMONY SITES

Background:

- Prior to 2022, Professional Photographers were allowed at dispersed sites within GTNP
- Currently the new implemented rules allow all traffic at these dispersed sites, except for Professional Photographers.
- These new regulations limit weddings with a photographer to only 6 locations. Busy/high traffic areas.
- This does not solve the congestion issue, and instead, would only amplify it.

Our Argument:

- The 6 places allowed are some of the most congested areas right off the highway, parking lot view points, places cars drive by and at times people honk their horns.
- We staunchly contend that having a Professional Photographer does not negatively impact the public's enjoyment of the Park at these ceremony sites. In fact, visitors are absolutely thrilled to witness these special moments within the Park.
- This is illegal per code 54 U.S.C. § 100905(c)(1) From NPPA's letter "The further requirement that professional photographers may only document "site-specific" weddings, which are not permitted during the winter season, and the ban on photographers at smaller wedding ceremonies that are allowed elsewhere in the park and during the winter, results in a complete ban on wedding photography during seven months of the year as well as a complete ban on wedding photography in the vast majority of the park locations where wedding photography can take place."

Solution:

- Professional Photographers to be allowed at dispersed ceremony locations
 - If worried about impact, a limit of persons could be an option, include the photographer in the limit of 12.

Appeal #3. DISCUSS PERMIT CAPS, LOCATIONS & TIMES

Background:

- Prior to 2022 (since 1929), there were no limits on how many weddings could take place per location. While we understand that weddings cannot occur without limit, a change from no limits to 1 per day, only for 156 days of the year is drastic.
- Per new 2022 CUA regulations, permits are provided for six (6) site-specific ceremony locations that only allow 1 ceremony permit per day.
- These are limited to only 60 per year per location (with the exception of Colter Bay Swim Beach, which is limited to a maximum of 30 per year) only between the dates of May 13, 2022 October 16, 2022.

Argument:

- Restricting photographers and visitors (that are clients) from areas that the general public is allowed is discrimination.
- Add the following locations back as options for ceremony sites:
 - Locations that people want are:
 - Oxbow
 - Cathedral Viewpoint
 - Jenny Lake
 - Taggart Lake
 - Taggart Lake (trailhead)
 - Cascade Canyon Turnout
 - Blacktail Ponds Overlook
 - Signal Mountain
 - Cunningham Cabin
 - String Lake
 - Blacktail Ponds Overlook

Proposed solution:

- Add winter months access
 - There should be allowed wedding permits from October 17th, 2022 May 12th 2023 (and years ahead) & Prior to May 12th 2022.
- Add more locations allowed for designated ceremonies
- Permit cap of 2 per day year round,

APPEAL #4. REMOVE LIMIT OF 1/2 MILE FROM THE TRAILHEAD/PARKING LOTS

Background:

• Per new 2022 SUP regulations, professional photographers are not allowed to go past ¹/₂ a mile from the trailhead/parking lots.

Our Argument:

- This creates further congestion and overuse of areas
- Photographers are no longer allowed to document wedding hikes or hiking proposals
- Restricting photographers and visitors (that are clients) from areas that the general public is allowed is discrimination.

Requested Changes:

• Allow Professional Photographers and visitors/clients beyond ½ a mile past a trailhead.

Appeal #5. REMOVE REQUIREMENT OF COMMERCIAL USE AUTHORIZATIONS

Background:

• CUAs are now required for wedding and portrait photographers as of 2022

Our arguments

- This is illegal per code 54 U.S.C. § 100905(c)(1)
 - No commercial photographer should be required to:
 - Have CPR first aid classes
 - Send in financials monthly
 - Pay 3-5% additional "management" fees based on their revenue
 - Wear name tags
 - Have business logos on cars
 - Have their rates determined by the superintendent
 - Be responsible for clients behavior or activity. From CUA requirements: "Guides will ensure that clients are properly prepared for the authorized activity."
 - Be forced to give the "United States of America access to its books at any time for the purpose of determining compliance with the terms and conditions of this authorization."
 - Should not be "responsible for determining whether Wyoming state or local laws allow the possession of firearms by their clients."

Proposed solution:

 Rescind the most recent CUA permit requirement for portrait photography as it is not legal or appropriate.

Summary:

We urge the Park to reexamine their perspective on ceremonies as a whole and we beseech the CUA office to acknowledge our arguments and reevaluate and rework these most recent ceremony changes, lift the unconstitutional and illegal policies, and implement common sense procedures. We are also seeking clarity of rules, peaceful, timely and unbiased permit processes and mutual respect moving forward.

Let us remember the words by founder President Theodore Roosevelt that our National Parks are "For the Benefit & Enjoyment of the People" & President Franklin D. Roosevelt: "There is nothing so American as our national parks.... The fundamental idea behind the parks...is that the country belongs to the people, that it is in process of making for the enrichment of the lives of all of us." - *Radio Address from Two Medicine Chalet, Glacier National Park (August 5, 1934)*

We can balance the enjoyment of the land with the preservation of it for future generations. These new restrictions do neither.
